CALL TO ORDER

President Eagle called the meeting to order at 6:00 P.M.

President Eagle established the existence of a quorum, with the following members present: Ms. Eagle, Ms McCreary, Mr. Mettler, Ms Morris, and Mr. Kizaraly.

The agenda was approved as submitted.

CLOSED SESSION

The Board accepted the resignation of Barbara Berman as Director of Discovery II.

OPEN SESSION

Open Session began at 7:00P.M.

PUBLIC COMMENTS

None.

REPORT OF CLOSED SESSION

The Board acted on one personnel matter.

REPORTS

Discovery II Teacher Report – Ms. DeMartini and Mr. Wright presented projects and teaching methodology used in Grades 4 & 5. Students presented projects and student led learning activities.

Discovery II PSC Report – Ms. Lund presented Program Site Council activities. A leadership transition plan to overlap officer terms by one year has been established. All but 9 families have a schoolwide job assigned. The PSC has facilitated many recent community events, with an Earth Day event and the Spring Fun Fair coming up. The Parent Ed team now has 2 teachers participating.

Financial Update – Cheryl Leong from EdTec presented a budget update.

Superintendent/Executive Director Report

The Superintendent/Executive Director reported on the following:

• The transition of Mr. Jones to Discovery II and Ms. Perry to Discovery I Director is going well.

- Staff Learning Days were held for both campuses.
- Parent surveys were conducted at both campuses. Discovery I results were similar to previous years. Discovery II results were much more positive than last year. No major surprises came out of either survey.
- Discovery I students participated in a Middle School diversity conference for the second year.
- Discovery II teachers will participate in professional development training again at Opal School.
- Safety Report There were no safety items to report this month. However, several incidents with students from the Spectrum School have caused concern. Mr. Jones has notified SJUSD.

Director of Business Report

Enrollment – The Lotteries for both campuses are scheduled for next week. 411 students will be lotteried for Discovery II, 627 will be lotteried for Discovery I. As of March 24, 62 applications were received for the Home School program.

Funds Drive – Discovery I has collected approximately \$266,000 with 76% participation, Discovery II has collected approximately \$216,000 with 75% participation.

ACTION / DISCUSSION ITEMS

Mr. Jones presented a new fundraising program called Giving Privilege. The Board requested additional information.

The Board discussed the Home School program and details of its implementation on the Discovery II campus. Mr. Jones presented a preliminary budget for the program. The Lottery will be held at the end of April. The Board requested an updated budget.

The Home School lottery policy was discussed. One typo was found. On a motion made by Ms. Morris seconded by Ms. McCreary, the Board voted to approve Motion # 150324.1 to approve the Home School Lottery Policy as amended. Approved 5-0. Mr. Mettler – Aye, Ms. McCreary – Aye, Mr. Kizaraly – Aye, Ms. Morris – Aye, Ms. Eagle – Aye.

The Board discussed expansion of the Discovery II campus with three modulars to be purchased from a high school district. Enrollment projections can be met with this additional classroom space.

The Board discussed that the Strategic Plan should be reformatted and specific deliverables need to be defined in committee. On a motion made by Mr. Kizaraly, seconded by Ms. McCreary, the Board voted to approve Motion # 150324.2 to approve the Strategic Plan. Approved 5-0. Mr. Mettler – Aye, Ms. McCreary – Aye, Mr. Kizaraly – Aye, Ms. Morris – Aye, Ms. Eagle – Aye.

Board Committee Reports

Election Committe – Ms. McCreary will remind all incumbents to submit their Board election applications. No new applications have been received.
